Local councils in England with an annual turnover of £6.5 million or less must complete an annual return in accordance with proper practices summarising their activities at the end of each financial year. In this annual return the term 'local council' includes a Parish Meeting, a Parish Council and a Town Council.

The annual return on pages 2 to 5 is made up of four sections:

- Sections 1 and 2 are completed by the person nominated by the local council.
- Section 3 is completed by the external auditor appointed by the Audit Commission.
- Section 4 is completed by the local council's internal audit provider.

Each council must approve this annual return no later than 30 June 2015.

Completing your annual return

Guidance notes, including a completion checklist, are provided on page 6 and at relevant points in the annual return.

Complete all sections highlighted in green. Do not leave any green box blank. Incomplete or incorrect returns require additional external audit work and may incur additional costs.

Send the annual return, together with your bank reconciliation as at 31 March 2015, an explanation of any significant year on year variances in the accounting statements and any additional information requested, to your external auditor by the due date.

Your external auditor will identify and ask for any additional documents needed for their work. Therefore, unless requested, do not send any original financial records to the external auditor.

Once the auditor has completed their work, certified annual returns will be returned to the local council for publication or public display of sections 1, 2 and 3. You must publish or display the annual return, including the external auditor's report, by 30 September 2015.

It should not be necessary for you to contact the external auditor for guidance.

Matters reported

Risk Assessment

The council has not taken undertaken a risk assessment.

A risk assessment should be performed at least annually and as a minimum, members should: -

- take steps to identify the key risks facing the parish council
- evaluate potential consequences to the council if an event identified as a risk takes place; and
- decide upon appropriate measures to avoid, reduce or control the risk or its consequences. This might involve insurance or the implementation of internal controls.

More guidance on risk management can be found in the NALC / SLCC publication "Governance and Accountability for Local Councils – A Practitioners Guide (England)" at paragraphs 2.99 to 2.116.

Internal Controls

The previous clerk has confirmed that a system of internal control was not followed during the year 2014/15 and internal policies such as the financial regulations, standing orders, code of conduct and risk assessment were not reviewed during the year 2014/15. Despite being advised by the internal auditor that action needed to be taken, no such action was undertaken by the council.

However, we are aware that the council is taking action on this matter and all the necessary policies and internal controls are being updated and approved by the council.

Section 1 Comparatives

The figures for 31 March 2014 in Boxes 2,3 and 4 have not been restated from the figures presented on the 2014 Annual Return following the other matters noted in last year's external auditor's report. Box 2 should state £4,317 and Box 3 should state £683 and Box 4 should state £2,073.

Trust funds

Assertion 9, Section 2 currently states "No". The council does not act as a sole managing trustee. Therefore, the correct response is "Not covered".

Bank reconciliations

The internal auditor has stated that periodic bank reconciliations have not been carried out during the year 2014/15. It is good practice for the council to complete periodic reconciliations.

Internal Audit

The council has answered "No" to Assertion 6, Section 2. Section 4 has been fully completed and evidence provided suggests that the council has maintained an effective system of internal audit during the year 2014/15 with the audit report being completed before the approval of the Annual Return. Therefore, we feel the correct response is "Yes".
