#### 066/18 REPORTS - Ward Cllrs Report

The reorganisation of health administration in the area is being conducted very much behind closed doors so that even the Panel is not privy, at this stage, as to how or in what way they are developing.

#### 070/18 NORTH SOMERSET COUNCIL MATTERS

Stonebridge Farm: Awaiting NSC update. No further complaints received.

**A370 Footpath:** Flailing due end of June. NSC area engineer has placed a work order for the clearing two 5 metre sections of footpath - one near Bow Cottage and one towards the Beacon Works - to assess what will be involved in clearing the worst areas of the whole route. He also took photos of sections where he and the Clerk had to step off into the road to reach an intended site and to access a bus stop.

Puxton Road Drainage at Wyndham Grange & Puxton Lane Grip: Works awaited.

Puxton Road Gully at Council Houses: Jetting date awaited.

**Potholes: Maysgreen Lane/Puxton Road Junction:** Jet-patcher date awaited. This machinery has more work to do than can be completed during its current hire period, so it is not guaranteed that the work will be done during this summer. If it cannot be, the Area Engineer will keep it going with temporary fills.

St Anne's Car Park: The lease transfer from NSC to Priory Academy Trust is progressing.

**East Hewish Rail Crossing:** Area Engineer & Clerk visited the site. A grit bin is being ordered and will be sited it at a point adjacent to the crossing on the East Hewish side - in the lay-by (to the left facing the crossing).

**2018-19 Accounts:** pre-circulated with meeting papers, reviewed and noted.

**Community Fund:** The signatory additions of Cllrs Corbett and Howard as Cllr Popperwell was away for two weeks were ratified. The executed documents providing the Village Hall with £40,000 from the Community Fund towards their purchasing of the Freehold were also ratified. This provision is in the form of a non-interest bearing first charge on the land. There will be no repayment of the amount due except under prescribed circumstance relating to the closure or sale of the Hall.

#### **073/18 PLANNING** (Enforcement Report March 2018)

**New: 18/P/2929/FUL** Stable on field off Puxton Moor Lane. Despite the clarity and sincerity of this application, it raised several concerns among Members.

- Possible effects on the area as a Site of Special Scientific Interest (SSSI)
- Precedent being set in relation to other land owners along Puxton Moor Lane
- Drainage on this flood zone 3A land in relation to the proposed hard standings and water run off from the structures.
- The involvement of the Internal Drainage Board needed re adequate provisions for ensuring that manure and manure heaps were not located in a manner or position that might contaminate the surrounding rhynes.

The meeting concluded that, if Officers are minded to approve the application, then there should be a rigorous examination of necessary attached conditions, including those indicated above. Clerk to submit this response to NSC Planners.

Decisions Due: 18/P/2548/FUH Clover Cottage extension 17/P/2567/F Heathfield pitches.

**Granted:** 18/P/2668/FUH Apple Tree Cottage extension.

Refused: 18/P/2612/FUH Rosemary Cottage annexe. Appeal on same denied to the then resident in 2007.

Appeal: re 16/P/2843/F Storage containers at Heathfield Park. Dismissed Nov 17 but not notified to PPC.

**Enforcement:** possible planning infringement in close-boarded field adjacent to SJH Machinery. The new owner attended the meeting and explained in the public session that the boarding was to the gateway and road-side of the field only. It was to improve security both in relation to its providing unauthorised access to the adjacent property and to prevent fly tipping. The meeting felt the argument to be reasonable. Clerk to so inform NSC Enforcement.

#### 074/18 COUNCILLORS' REPORTS

#### **Cllr Corbett:**

- **1. Maysgreen Lane:** in the area opposite the Cheese Factory the highway has severely fallen away at its edge and has become a significant hazard to the less robust vehicles using the road. Clerk to report to Area Officer.
- 2. Traffic Management at Puxton Lane/Road Triangle: The speed of current traffic poses a potentially serious danger to drivers. We have an old fashioned country triangle that used to be accessed cautiously from all directions. Today it is increasingly a rat run for pre-occupied and urgent commuters. A collision especially from those turning towards the bridge and those coming from the bridge into Puxton Road is sure to happen eventually. Is there some form of one-way system that can be clearly signposted such that traffic can be both clearly managed through this hazard and can clearly understand the potential danger of it? Clerk to investigate and report back.
- **3. Broken street sign at Puxton Road/Lane junction:** Clerk reported that repositioning was planned, and will chase.

#### **Cllr Popperwell:**

**Fly-tipping in Hall car park:** This was reported by a resident. The meeting understands that its clearance has been intended but not attended to due to the pressure of the Hall purchase activities. Representatives of Hall management have undertaken to arrange clearance.




