8. **NORTH SOMERSET COUNCIL MATTERS**  
**Maysgreen Lane:** Re-set of 30mph signs due.  
**A370 Street Light:** at the J21 side of the Wick Lane junction repaired - SSE looking at again.  
**St Annes Graveyard Hedges:** NSC site meeting due. Damage to the graves, also needs attention.  
**Stonebridge Farm:**  
**A370:** J21 traffic lights re-synched; if working correctly yellow boxes not needed.  
**Blocked Gullies from J21 to SJH Machinery:** Clerk to report - there is a history of flooding relating to these.
