Minutes of the Meeting on Thursday 2nd March 2017 at 7.30pm in Village Hall

- **29/17 APOLOGIES FOR ABSENCE -** Cllrs Corbett, Edwards and Wilson
- **30/17 DECLARATIONS OF INTEREST None**
- **PUBLIC SESSION** Concerns re Stonebridge farm, and broadband are addressed within Minutes 32/17 and 38/17 below.

Loose cover on A370 opposite Heathgate Paddock causing severe noise nuisance. Clerk to report. **St Annes Graveyard hedges** is serious need of attention. Clerk to liaise with responsible authority.

32/17 REPORTS - Ward Cllrs Report - Cllr Leimdorfer.

Council meeting 21st February: Concerns about *NHS funding* cuts versus the needs of the Sustainability & Transformation Plans. Council noted need for adequate funding of social care. *Council Tax* rise of 4.75% including 3% precept for social care. Despite this, there will be significant service cuts as social care budget already 4% overspent. *Weston Town Centre Regeneration* Supplementary Planning Document approved.

Health Overview & Scrutiny Panel: Cllr Leimdorfer reported an informal briefing on the Weston Hospital Sustainability Plan from James Rimmer (CEO of WHAT), Dr. Mary Backhouse (Clinical Lead, North Somerset CCG) and Mike Jackson (CEO of North Somerset). A public consultation has been launched - Cllr Leimdorfer outlined some critical issues such as overnight accident and emergency cover: Clerk's note: all issues are fully explained in a consultation document available on our Parish website noticeboard - visit <u>www.puxtonparishcouncil.org.uk</u>.

Planning & Regulatory Committee: The Wrington Lane Gladman application was approved, but may be subject to appeal. There is consultation on proposals for 24 homes on land behind Sousta restaurant on the A370 on land adjoining Station Close. Congresbury Parish Council are in favour. An application for 5 homes at Withydale Farm on the Old Weston Road (off the A370) will have a recommendation for approval. These seemingly exceptional decisions result from Congresbury being one of North Somerset's 9 service villages.

Stonebridge Farm, A370: Extensive works necessitate many HGV movements over several months. There have been complaints about a great deal of mud on the road both towards Congresbury and the M5, HGV movements well before the designated time of 8.00am and the state of the bus stop. Anthony McDonagh, owner of Stonebridge Farm, explained that there is pressure to complete the work within the next three months. He undertook to clear the surrounding area of mud and debris and to communicate the concerns to Keyways, the sub-contractors who own the HGVs. It was agreed to invite a representative of Keyways to the next Parish Council Meeting if there is evidence of an ongoing problem. Clerk to monitor and progress as needed.

Land opposite the Full Quart: there are ongoing issues, including sheep escaping onto the A370.
